Toyota Technical Development Corporation (TTDC, Head Office: Toyota, Aichi, President: Yoshiyuki Kagawa) hereby announces that it has completed the necessary procedures to acquire all shares of AI Samurai Inc. (Head Office: Chiyoda-ku, Tokyo, CEO: Hajime Shirasaka) and turn AI Samurai into a fully owned subsidiary of TTDC. Going forward, TTDC intends to maximize the strengths of both companies to further support the development of the intellectual property (IP) field through the provision of AI-based services.

Background and Objective

Based on the know-how that TTDC has accumulated as the IP partner of Toyota Motor Corporation and the Toyota group, we are dedicated to supporting the IP practices of our customers through activities such as the development of Swimy, a unique platform that facilitates invention creation and patent rights acquisition.
